Notice from Dave

Comment regarding e-mails- Since I am maximizing our "outreach" to members through our website e-mails, I want to offer some suggestions...

- If you choose to send an e-mail to all of the club members, please be clear on the "subject line" what your e-mail is about. That way, other club members can be comfortable that it is a legitimate e-mail.
- If you receive an e-mail that "appears" to be from another COB member, but the subject is not clear... or you look at the other recipients of the e-mail and don't recognize them as "COB members"... <u>delete the e-mail</u>. In this world of scammers and hackers, there will always be someone out there trying to spread something malicious... so play on the side of being safe.
- Never open an attachment unless you expect it, you're positive you know what it is, and that you trust the sender.
- Never click on a link in an email message unless you're positive you know where it's going and that you trust the sender.
- Over the years, I have received several e-mails from what appear to be COB members... but they don't look quite right... the subject is questionable, the spelling or grammar is off, etc. They usually contain some sort of link. I delete it and that is all I do. I don't discuss it... and I don't panic about it.
- We depend on our e-mail communication between members. If you get something questionable and don't know what to do... ask me. <u>Don't assume that just because another member's e-mail address has been "used" in a bogus e-mail from an unknown sender... that the member "has a virus".</u> Please be prudent before you "click" on anything and be protective of other COB members.
